**Dorset County Council (A Bridleway at Upton Heath, Corfe Mullen from Bridleway 45,
Corfe Mullen to Bridleway 7, Lytchett Minster)
Definitive Map and Statement Modification Order 2014**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 13 November 2014.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (A Bridleway at Upton Heath, Corfe Mullen from Bridleway 45, Corfe Mullen to Bridleway 7, Lytchett Minster) Definitive Map and Statement Modification Order 2014".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Modification of definitive map Description of way to be added

A – B – C A bridleway over an open sandy track across Upton Heath from its junction
– D – E – with Bridleway 45, south of Beacon Road at point A (SY 98909507), west
F – G – H across open heathland then south west to point B (SY 98759504), west north
– I – J – K west and north west to point C (SY 98719506), continuing north west to point
– L – M – D (SY 98689511) and then north alongside steps up to point E (SY
N – O 98679516). Continue generally west to a small clump of trees at point F (SY
98499520), then generally south west down the hill to a wooded area at point
G (SY 98429504), then generally south west alongside the woodland and
across a bridge at point H (SY 98299494) and continuing south west to
woodland at point I (SY 98209478). Continue south west up a steep bank to
point J (SY 98179474), then south east to point K (SY 98199472) and west
south west and south south west to point L (SY 98079457), south west to
point M (SY 98019450) then turning south east, parallel with Bridleway 7,
Lytchett Minster (Beacon Hill Lane), to point N (SY 98059443) and then west
to its junction with Bridleway 7, Lytchett Minster at the parish boundary at
point O (SY 98049443).

The width of the Bridleway varies:

Point A – 5 metres

Between points A and B – 3 metres

Point B – 2 metres

Between points B, C and D – 2 metres

Between points D, E and F – 1.5 metres

Point F – 1.5 metres

Between points F, G and H – 2 metres

Bridge at point H – 0.9 metres

Between H and I – 2.5 metres

Point I – 2.5 metres

Between points I and M – 2 metres

Point M – 1 metre

Between points M and N – 1 metre

Point N – 2 metres

Between points N and O – 2 metres.

A Bridleway in the parish of Corfe Mullen in the East Dorset District:

A bridleway over an open sandy track across Upton Heath from its junction with Bridleway 45, south of Beacon Road at SY 98909507, west across open heathland then south west to SY 98759504, west north west and north west to SY 98719506, continuing north west to SY 98689511 and then north alongside steps up to SY 98679516. Continue generally west to a small clump of trees at SY 98499520, then generally south west down the hill to a wooded area at SY 98429504, then generally south west alongside the woodland and across a bridge at SY 98299494 and continuing south west to woodland at SY 98209478. Continue south west up a steep bank to SY 98179474, then south east to SY 98199472 and west south west and south south west to SY 98079457, south west to SY 98019450 then turning south east, parallel with Bridleway 7, Lytchett Minster (Beacon Hill Lane), to SY 98059443 and then west to its junction with Bridleway 7, Lytchett Minster at the parish boundary at SY 98049443.

SY 98909507 – 5 metres

Between SY 98909507 and SY 98759504 – 3 metres

SY 98759504 – 2 metres

Between SY 98759504, SY 98719506 and SY 98689511 – 2 metres

Between SY 98689511, SY 98679516 and SY 98499520 – 1.5 metres

SY 98499520 – 1.5 metres

Between SY 98499520, SY 98429504 and SY 98299494 – 2 metres

Bridge at SY 98299494 – 0.9 metres

Between SY 98299494 and SY 98209478 – 2.5 metres

SY 98209478 – 2.5 metres

Between SY 98209478 and SY 98019450 – 2 metres

SY 98019450 – 1 metre

Between SY 98019450 and SY 98059443 – 1 metre

SY 98059443 – 2 metres

Between SY 98059443 and SY 98049443 – 2 metres.
