**Dorset County Council (Upgrading Bridleway 57, Corscombe
(Ford Lane) to Restricted Byway)
Definitive Map and Statement Modification Order 2014**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 8 July 2014.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Upgrading Bridleway 57, Corscombe (Ford Lane) to Restricted Byway) Definitive Map and Statement Modification Order 2014".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Part I

Modification of definitive map Description of way to be upgraded

Bridleway 57, Corscombe (Ford Lane) in the West Dorset District to be upgraded to Restricted Byway:

A – B – C A double hedged, unsurfaced path from its junction with the road, Bridleway
– D 56 and Footpath 24 south of St Mary's Church near Ford Cottage at point A (ST 52260450), south to its junction with Footpath 35 at point B (ST 52260445) then south south east to point C (ST 52350415), where the path widens at an access to a field. Continue south and south east to its junction with Catsley Lane at point D (ST 52490386).
The width varies:
ST 52260450 – 6 metres. Between ST 52260450 and ST 52260445 – 4 metres. ST 52260445 – 7.3 metres. Between ST 52260445 and ST 52350415 – from 4.8 metres at its widest point to 3.1 metres at its narrowest point.
ST 52350415 – 8.8 metres. Between ST 52350415 and ST 52490386 – from 5.45 metres at its widest point to 4 metres at its narrowest point.
ST 52490386 – 8 metres

Restricted Byway 57, Corscombe

A double hedged, unsurfaced path from its junction with the road, Bridleway 56 and Footpath 24 south of St Mary's Church near Ford Cottage, south to its junction with Footpath 35 at ST 52260445 then south south east to ST 52350415 where the path widens at an access to a field. Continue south and south east to its junction with Catsley Lane.

The width varies:

ST 52260450 – 6 metres. Between ST 52260450 and ST 52260445 – 4 metres. ST 52260445 – 7.3 metres. Between ST 52260445 and ST 52350415 – from 4.8 metres at its widest point to 3.1 metres at its narrowest point.

ST 52350415 – 8.8 metres. Between ST 52350415 and ST 52490386 – from 5.45 metres at its widest point to 4 metres at its narrowest point.

ST 52490386 – 8 metres.

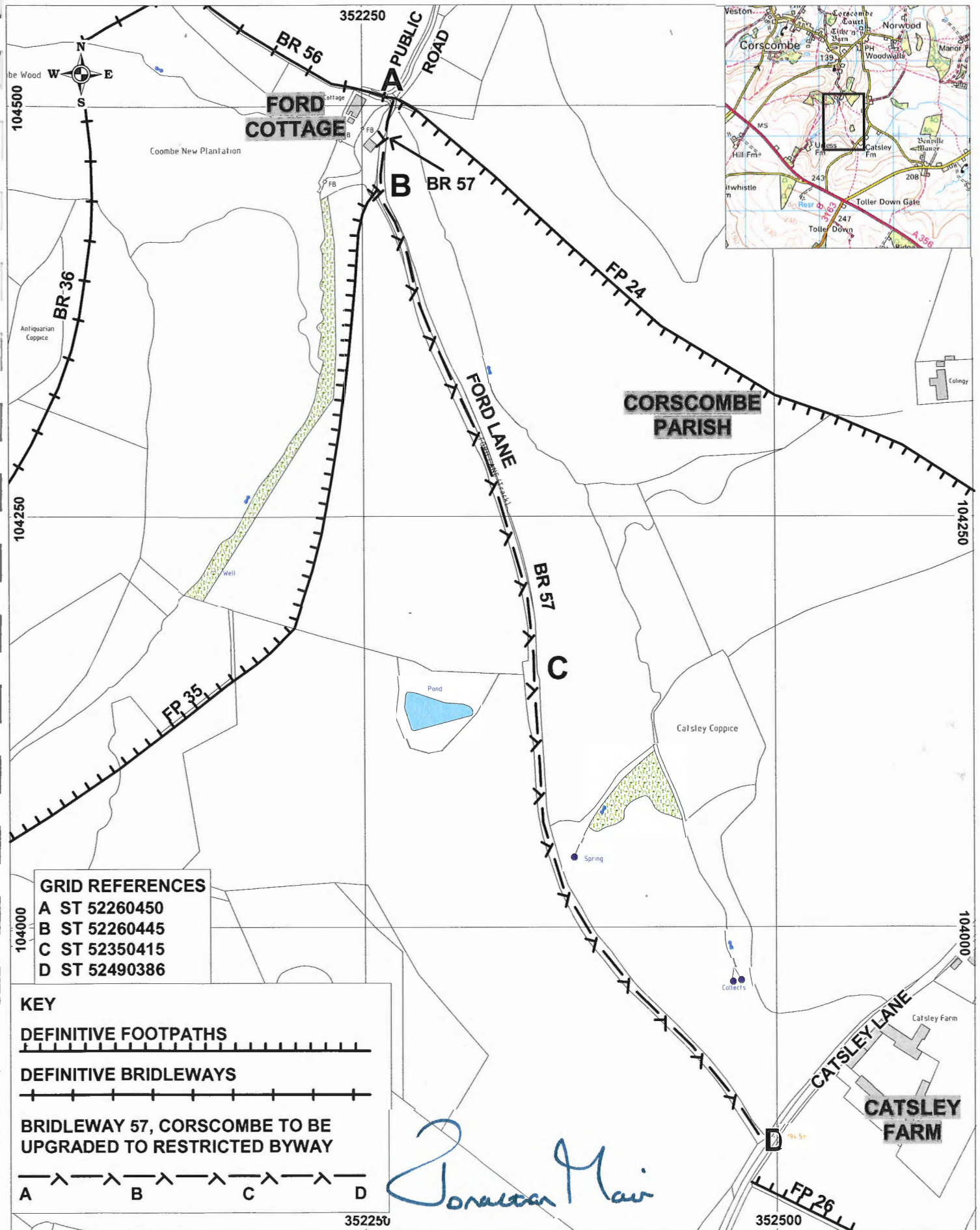
