**Dorset County Council (Bridleways 38 (part) and 39, Long Bredy (Broom Hill Lane) to  
be Upgraded to Restricted Byway)  
Definitive Map and Statement Modification Order 2014**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 10 September 2014.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleways 38 (part) and 39, Long Bredy (Broom Hill Lane) to be Upgraded to Restricted Byway) Definitive Map and Statement Modification Order 2014".

## SCHEDULE

(The points specified relate to the maps attached to the Order and their positions are identified by national grid references)

### Part I

#### **Modification of definitive map Description of ways to be upgraded**

Bridleways known as Broom Hill Lane in the parish of Long Bredy in the West Dorset District to be upgraded to Restricted Byways:

Part of Bridleway 38 (to be renumbered as part of Restricted Byway 39)

A – B – C From its junction with the A35 road, south east of North Barn Farm at point A (SY 56979135), a tarmac surfaced path, north north west, via point B (SY 56969138), to its junction with the current Bridleway 39 at point C (SY 56969140). The width of this part of Bridleway 38 is 6 metres.

Limitation: Field gate at point C (SY 56969140) to BSS709: 2006.

Bridleway 39

C – D – E From its junction with Bridleway 38, south east of North Barn Farm at point C  
– F – G – (SY 56969140), a grass surfaced path, hedged and fenced on both sides,  
H – I – J north north east and north east to point D (SY 57069162), continuing north to the edge of the wood at point E (SY 57079184). Then generally north east, through woodland, north east of North Barn Farm to point F (SY 57389224), continuing north, to the west of the pond at point G (SY 57429265) and north north east through woodland to point H (SY 57619329). Continue north north east along the edge of the wood to the western corner of the car park at point I (SY 57719361), then north north east, a gravel surfaced path, to its junction with Bridleways 6 and 8, Compton Valence and the Roman Road at point J (SY 57729364).

The width varies: 6 metres between point C (SY 56969140), point D (SY 57069162) and point E (SY 57079184); 6 metres at point E (SY 57079184) widening to 7.5 metres at point F (SY 57389224) and narrowing to 7 metres at point G (SY 57429265); and narrowing to 5.6 metres at point H (SY 57619329), 5.4 metres at point I (SY 57719361) and 5.3 metres at point J (SY 57729364).

Limitations: Field gates at point C (SY 56969140) and point I (SY 57719361) to BSS709: 2006.

#### **Modification of definitive statement Variation of particulars of ways**

#### **Delete:**

Bridleway 38, Long Bredy

From: 569913 To: 564925

From junction with Bridport/Dorchester road at Long Bredy Hut generally north westerly via North Barn to join Path No 37, Long Bredy.

**Add:**

Bridleway 38, Long Bredy

From: SY 56969140 To: 564925

From its junction with Restricted Byway 39, generally north westerly via North Barn to join Path No 37, Long Bredy.

**Delete:**

Bridleway 39, Long Bredy

From: 569913 To: 577936

From junction with Path No 38, Long Bredy north of Long Bredy Hut generally northwards to Roman Road.

**Add:**

Restricted Byway 39, Long Bredy

From: SY 56979135 To: SY 57729364

From its junction with the A35 road, south east of North Barn Farm, a tarmac surfaced path, north north west, via SY 56969138, to its junction with Bridleway 38 at SY 56969140.

Continue north north east and north east, a grass surfaced path, hedged and fenced on both sides to SY 57069162, then north to the edge of the wood at SY 57079184. Then generally north east, through woodland, north east of North Barn Farm to SY 57389224, continuing north, to the west of the pond at SY 57429265 and north north east through woodland to SY 57619329. Continue north north east along the edge of the wood and the western corner of the car park at SY 57719361, then north north east, a gravel surfaced path, to its junction with Bridleways 6 and 8, Compton Valence and the Roman Road.

The width varies: 6 metres between SY 56979135, SY 56969138, SY 56969140, SY 57069162 and SY 57079184; 6 metres at SY 57079184 widening to 7.5 metres at SY 57389224 and narrowing to 7 metres at SY 57429265; and narrowing to 5.6 metres at SY 57619329, 5.4 metres at SY 57719361 and 5.3 metres at SY 57729364.

Limitations: Field gates at SY 56969140 and SY 57719361 to BS5709: 2006.

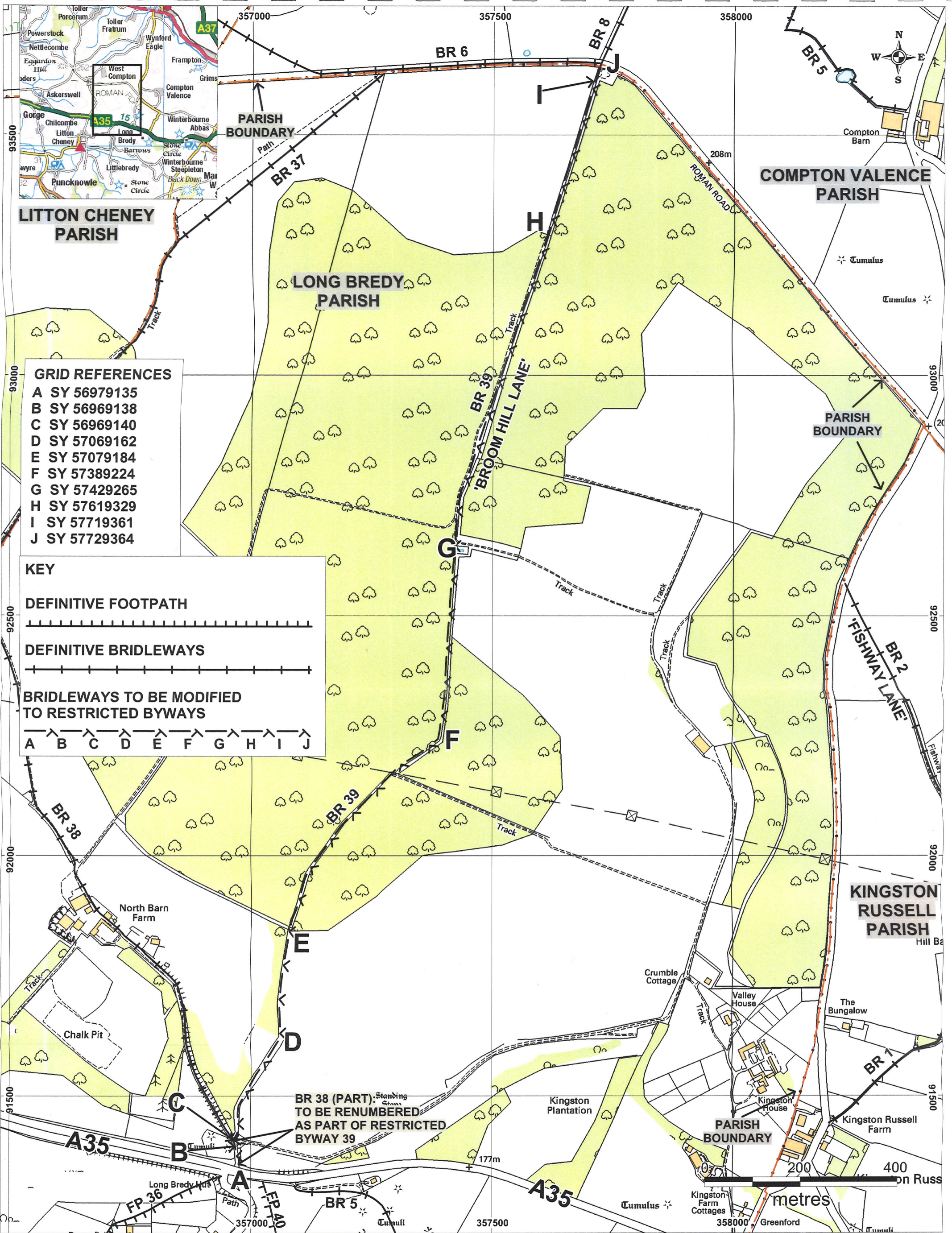
