**Dorset County Council (Upgrading Bridleway 7, Puddletown (Blind Lane) to
Restricted Byway) Definitive Map and Statement Modification Order 2014**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 6 March 2014.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.

This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Upgrading Bridleway 7, Puddletown (Blind Lane) to Restricted Byway) Definitive Map and Statement Modification Order 2014".

Modification of definitive map Description of way to be upgraded

Bridleway 7, Puddletown (Blind Lane) in the West Dorset District to be upgraded to Restricted Byway:

A – B From its junction with the A354 Blandford Road at Basan Hill, Puddletown at point A (SY 76549594), a double hedged, unsurfaced path west north west to its junction with the unclassified road from Druce to Dewlish at point B (SY 76019606).
Width: Point A – 6 metres, widening to 10 metres at point X, X – Y – 10 metres, narrowing to 6 metres at point B.
Limitations: None

Width: SY 76549594 – 6 metres, widening to 10 metres at SY 76359600, SY 76359600 – SY 76199603 – 10 metres, narrowing to 6 metres at SY 76019606.

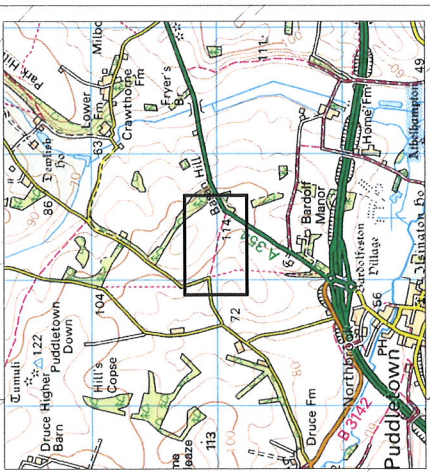
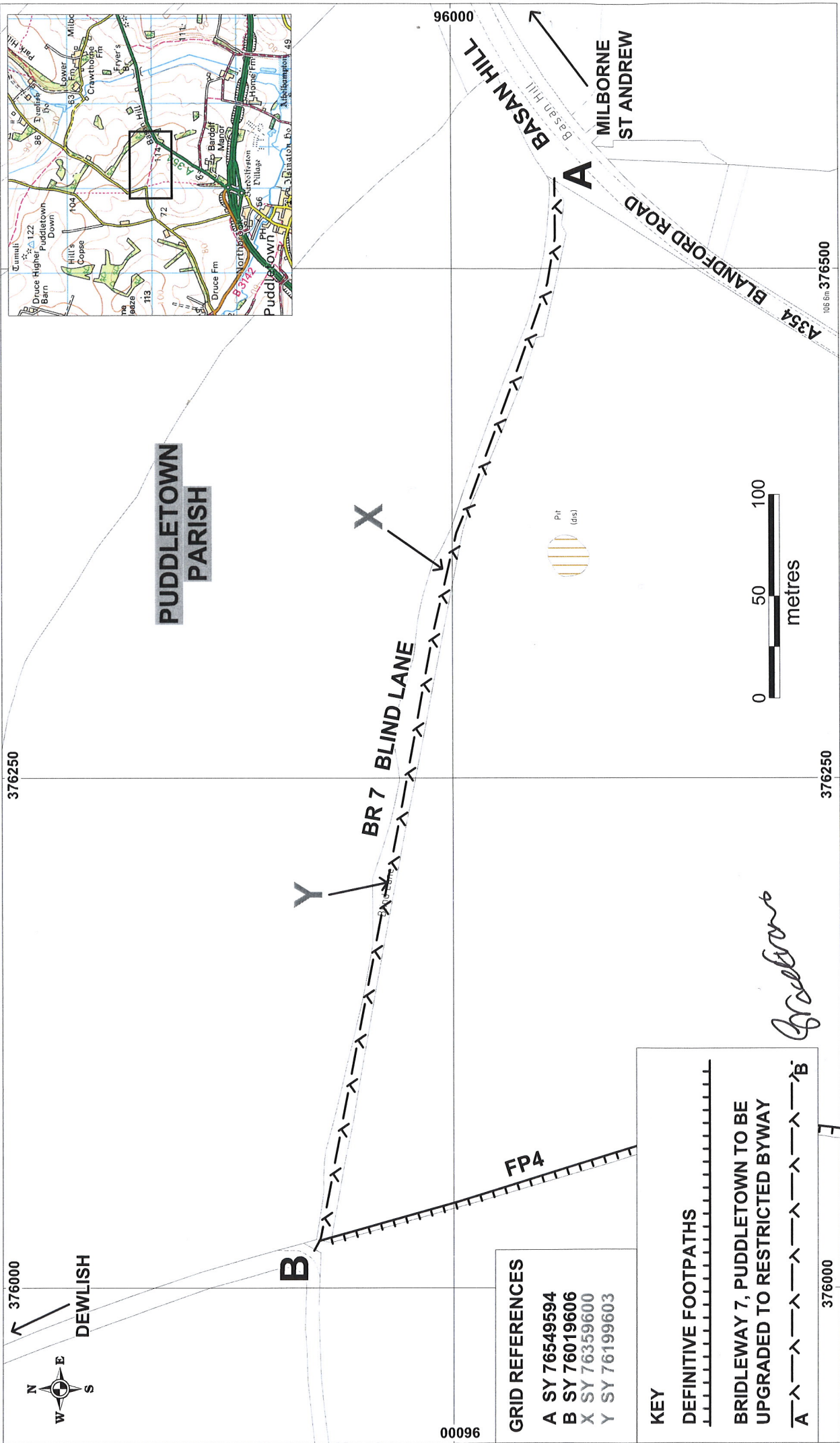
