**Dorset County Council (Upgrading Bridleway 3, Godmanstone to Restricted Byway and
adding a Restricted Byway to link with Fry's Lane, Godmanstone)
Definitive Map and Statement Modification Order 2013**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, section 53(3)(c)(ii), namely that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii), namely that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 25 November 2013.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Upgrading Bridleway 3, Godmanstone to Restricted Byway and adding a Restricted Byway to link with Fry's Lane, Godmanstone) Definitive Map and Statement Modification Order 2013".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Modification of definitive map

Description of way to be upgraded

Bridleway 3, Godmanstone in the West Dorset District (to be Restricted Byway 3)

B – A From its junction with the unrecorded part of Fry's Lane (to be added as Restricted Byway) at point B (SY 65859711), west south west and then west to its junction with Bridleway 5 at Crete Hill at point A (SY 65309709). Width: 9.1 metres (30 feet)

Description of way to be added

A Restricted Byway at Godmanstone in the West Dorset District (to be part of Restricted Byway 3)

C – B From its junction with the D20717 road known as Fry's Lane at point C (SY 65889710), west north west for a distance of 30 metres to its junction with Bridleway 3 (to be Restricted Byway 3) at point B (SY 65859711). Width: 9.1 metres (30 feet)

Variation of particulars of way

Delete:

Bridleway 3, Godmanstone

From: 658971 To: 653971
Lane west of Field Farm (width 30 feet) to join Path No 5, Crete Hill

Add:

Restricted Byway 3, Godmanstone

From: SY 65889710 To: SY 65309709
From its junction with the D20717 road known as Fry's Lane, generally west to its junction with Path No. 5 at Crete Hill. Width: 9.1 metres (30 feet)

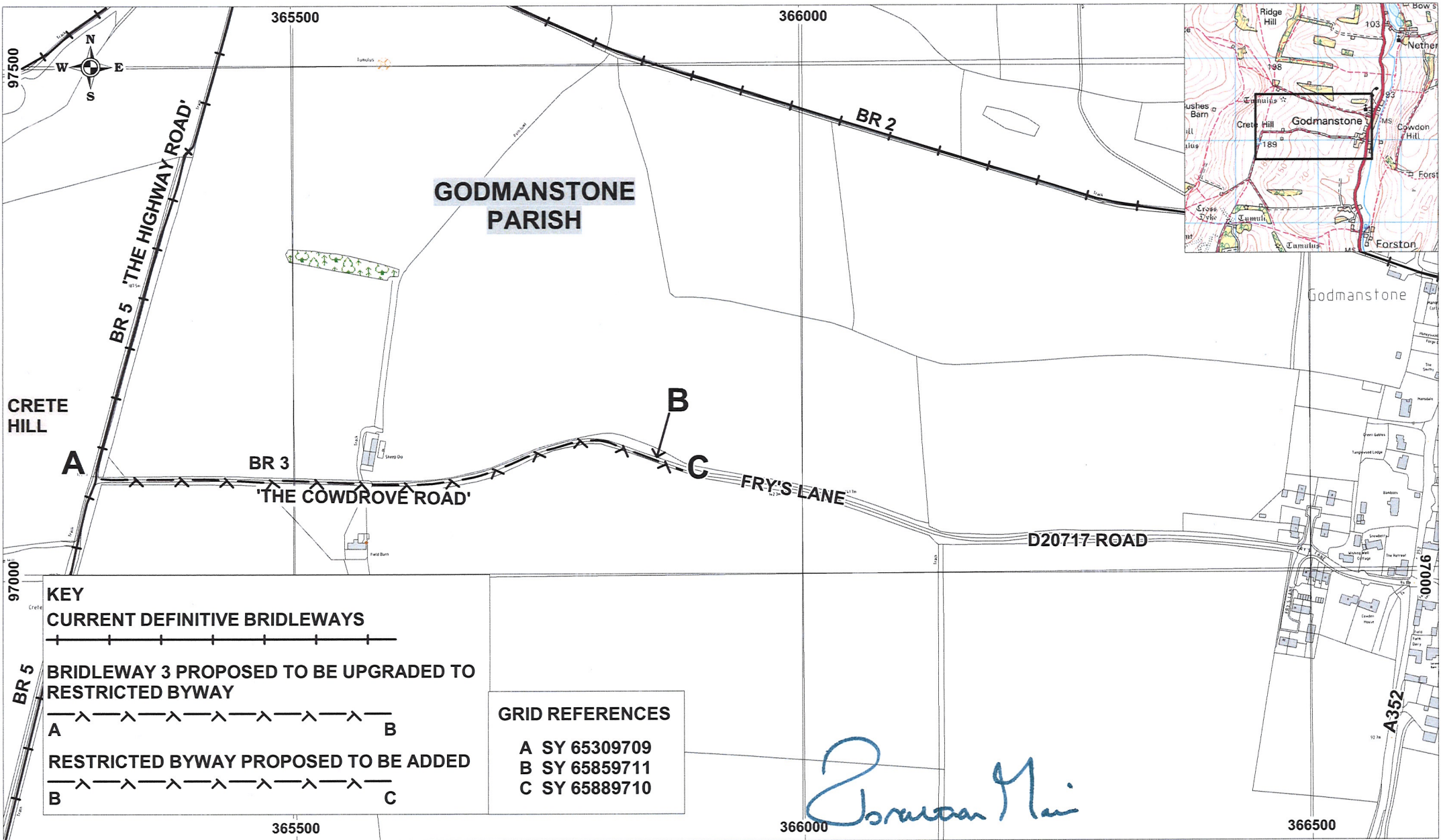
