Dorset Council (Bridleway 8, Turnworth to be upgraded to Restricted Byway) Definitive Map and Statement Modification Order 2025

This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

- 1. For the purposes of this Order the relevant date is 23 May 2023.
- 2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (Bridleway 8, Turnworth to be upgraded to Restricted Byway) Definitive Map and Statement Modification Order 2025".

I – J – K – From Bridleway 14, Okeford Fitzpaine at point I (ST 80440875), north east along a crushed stone track to point J (ST 80560888), east north east to its junction with Footpath 57 at point K (ST 80750897), continuing north east between farm buildings at point K1 (ST 81000919), then continuing east north east along the south boundary of the Okeford Hill car park and picnic site to its junction with the C32 County Road at point L (ST 81250932). (No recorded width)

Limitation Point L (ST 81250932) Bridle gate.


