### **Section 53 of the Wildlife and Countryside Act 1981**

#### **Dorset Council County of Dorset Definitive Map and Statement of Rights of Way**

#### **Dorset Council (Bridleway 39 (part), Weymouth and Bridleway 14 (part) Bincombe to be upgraded to Restricted Byways) Definitive Map and Statement Modification Order 2025**

The above Order, made on 29 May 2025, if confirmed as made, will modify the definitive map and statement for the area by:

**Bridleway 39 (part), Weymouth:**

*To be numbered Restricted Byway 167*

From the unaffected part of Bridleway 39, Weymouth at SY 66938612 south east along a crushed stone surface track to SY 66988607 south east to the parish boundary at SY 67018604.

Width 30 feet.

**Bridleway 14 (part), Bincombe:**

*To be numbered Restricted Byway 26*

From the parish boundary at SY 67018604 south east along a crushed stone surface track to the unaffected part of Bridleway 14, Bincombe and the County Road D90201 at the Roman Road at SY 67078600.

Width: 30 feet.
