Shitterton)
Definitive Map and Statement Modification Order 2015**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 14 May 2015.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (A Footpath from Footpath 30 to Footpath 34, Bere Regis at Shitterton) Definitive Map and Statement Modification Order 2015".

A Footpath in the Parish of Bere Regis in the West Dorset District:
To be numbered Footpath 55, Bere Regis

A – B – C From its junction with Footpath 30, south of Honeycombe Cottage, Shitterton at point A (SY 84099492), west along an earth and grass surfaced track for 34 metres to point B (SY 84069493), then north west along the track, hedged on the north eastern side, to its junction with Footpath 34, south west of Culverdell at point C (SY 84009497).
Width: 3.5 metres.

Part II

**Modification of definitive statement
Variation of particulars of path**

Footpath 55, Bere Regis

Add:

From: SY 84099492 To: SY 84009497
From its junction with Footpath 30, south of Honeycombe Cottage, Shitterton west along an earth and grass surfaced track for 34 metres to SY 84069493, then north west along the track, hedged on the north eastern side, to its junction with Footpath 34, south west of Culverdell.
Width: 3.5 metres.

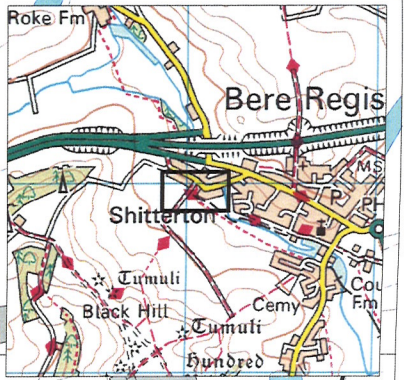
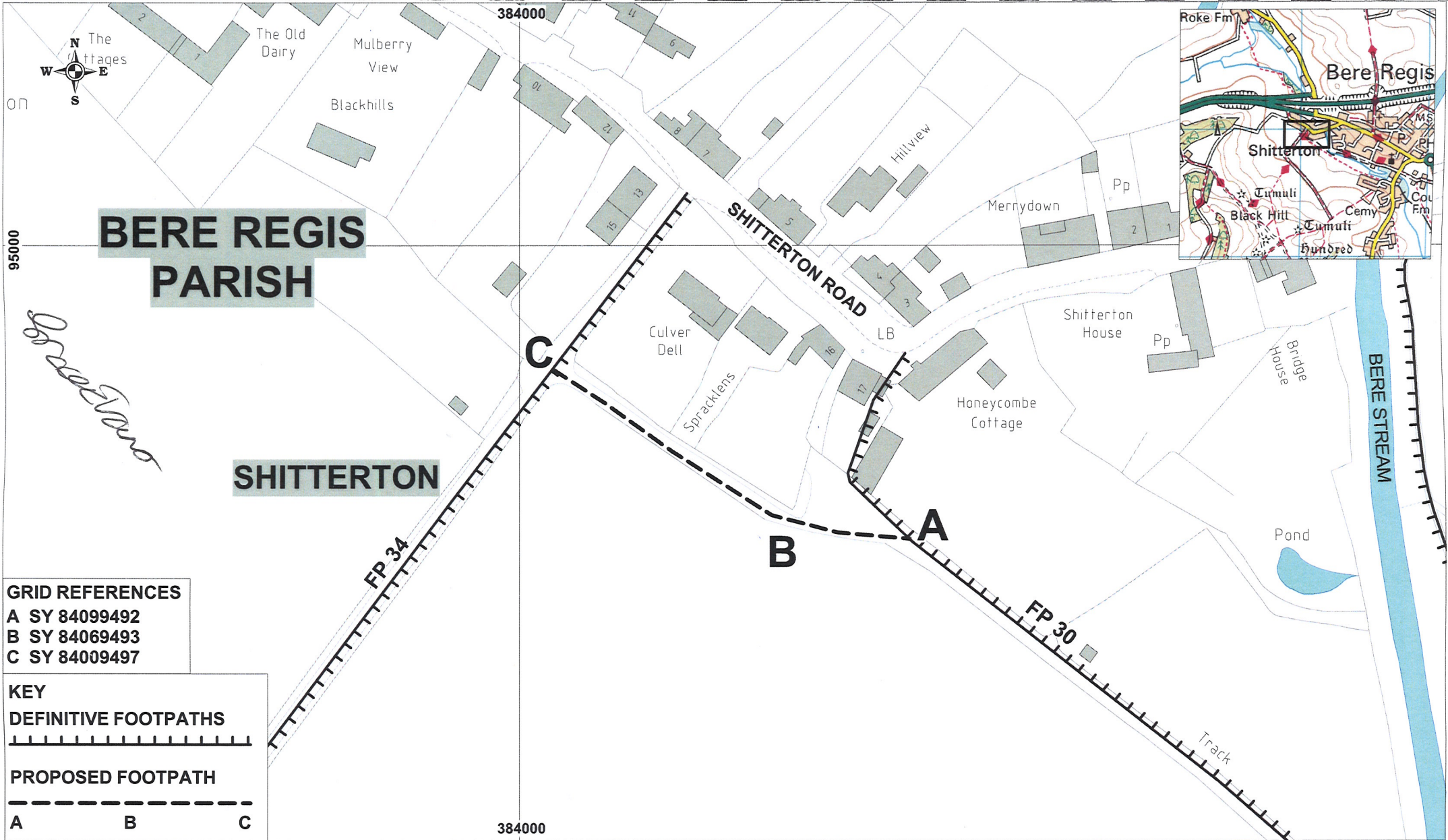
