**Dorset County Council (Footpath 21, Verwood to be upgraded to Restricted Byway and  
Bridleway) Definitive Map and Statement Modification Order 2014**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii), namely that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii), namely that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 12 March 2014.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Footpath 21, Verwood to be upgraded to Restricted Byway and Bridleway) Definitive Map and Statement Modification Order 2014".

## SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

### Part I

#### **Modification of definitive map Description of path to be upgraded**

#### **Footpath 21, Verwood in the East Dorset District:**

- A – B – C Part to be upgraded to Restricted Byway (Restricted Byway 21, Verwood), known as Crab Orchard Way, from its junction with the B3072 Verwood Road north of The Paddocks at point A (SU 08830677), a gravel/stone track, west north west past Crab Orchard Farm to its junction with Footpath 22 at point B (SU 08590687) and continuing west north west past Rushmore Farm to its junction with the remaining part of Footpath 21 (new Bridleway 42) and Footpath 8, Horton at the Horton parish boundary at point C (SU 08280700). Width: 11 metres
- C – D Part to be upgraded to Bridleway (Bridleway 42, Verwood), from its junction with Crab Orchard Way, Footpath 21 (new Restricted Byway 21), north of Rushmore Farm at the Horton Parish boundary at point C (SU 08280700), with part of the width stone-surfaced and part unsurfaced, south south west to its junction with Bridleway 20, Verwood and Bridleway 7, Horton (known as Sandy Lane) at point D (SU 08150667). Width: 7 metres

#### **Delete:**

#### **Footpath 21, Verwood**

From: 088068 To: 081067

Verwood Road at Crab Orchard to join Path No 20 (Sandy Lane) at the western end

#### **Add:**

#### **Restricted Byway 21, Verwood**

From: SU 08830677 To: SU 08280700

Crab Orchard Way, from its junction with the B3072 Verwood Road north of The Paddocks, a gravel/stone track, west north west past Crab Orchard Farm to its junction with Footpath 22 at SU 08590687 and continuing west north west past Rushmore Farm to its junction with Bridleway 42 and Footpath 8, Horton at the Horton parish boundary. Width: 11 metres

#### **Bridleway 42, Verwood**

From: SU 08280700 To: SU 08150667

From its junction with Crab Orchard Way, Restricted Byway 21, north of Rushmore Farm at the Horton Parish boundary, with part of the width stone-surfaced and part unsurfaced, south south west to its junction with Bridleway 20, Verwood and Bridleway 7, Horton (known as Sandy Lane). Width: 7 metres
