**Dorset County Council (Bridleway 6, Littlebredy and Bridleway 7, Winterbourne Steepleton to be Upgraded to Restricted Byways)  
Definitive Map and Statement Modification Order 2015**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 19 February 2015.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleway 6, Littlebredy and Bridleway 7, Winterbourne Steepleton to be Upgraded to Restricted Byways) Definitive Map and Statement Modification Order 2015".

## SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

### Part I

#### **Modification of definitive map Description of ways to be upgraded**

##### Bridleway 6, Littlebredy in the West Dorset District:

- A – B From its junction with the D11909 road, at the south western corner of Northfield Plantation at point A (SY 59968838), east, along a grass surfaced track, through woodland, to its junction with Bridleway 7, Winterbourne Steepleton at the parish boundary at point B (SY 60078838).  
Width: 8 metres.

##### Bridleway 7, Winterbourne Steepleton in the West Dorset District:

- B – C – D From its junction with Bridleway 6, Littlebredy at the parish boundary at point  
– E – F – B (SY 60078838), east, along a grass and earth surfaced track, fenced on the  
G – H northern side, then south east along the northern side of the woodland to its junction with Coombe Road at point C (SY 60398825). Continue south east from its junction with Coombe Road at point D (SY 60408824), through a small car parking area, along a mixed surfaced track fenced on the northern side, adjacent woodland, and continuing south east through a small area of woodland to point E (SY 60818793). Turn north east, close to the southern edge of the adjacent plantation, then generally east south east, through open countryside at Black Down to point F (SY 61448782). Continue south east, along a stone/gravel surfaced track, along the south western side of the woodland, to its junction with Bridleway 6 at point G (SY 61568774), then south south east to its junction with the C112 road at Smitten Corner at the Portesham parish boundary at point H (SY 61578774).  
Width: The width varies; 8 metres at point B (SY 60078838), 9.14 metres between points B (SY 60078838) and point E (SY 60818793), 4 metres between points E (SY 60818793) and point F (SY 61448782), 5 metres between points F (SY 61448782) and point H (SY 61578774).

From its junction with Restricted Byway 6, Littlebredy at the parish boundary, east, along a grass and earth surfaced track, fenced on the northern side, then south east along the northern side of the woodland to its junction with Coombe Road at SY 60398825. Continue south east from its junction with Coombe Road at SY 60408824, through a small car parking area, along a mixed surfaced track fenced on the northern side, adjacent woodland, and continuing south east through a small area of woodland to SY 60818793. Turn north east, close to the southern edge of the adjacent plantation, then generally east south east, through open countryside at Black Down to SY 61448782. Continue south east, along a stone/gravel surfaced track, along the south western side of the woodland, to its junction with Bridleway 6 at SY 61568774, then south south east to its junction with the C112 road at Smitten Corner at the Portesham parish boundary at SY 61578774.

Width: The width varies; 8 metres at SY 60078838, 9.14 metres between SY 60078838 and SY 60818793, 4 metres between SY 60818793 and SY 61448782, 5 metres between SY 61448782 and SY 61578774.

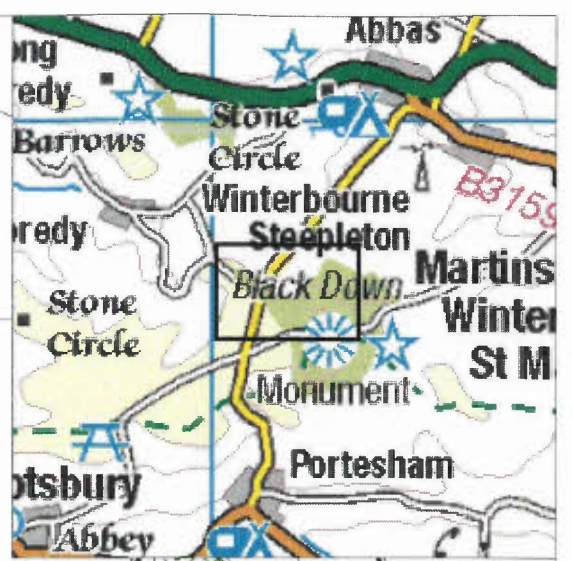
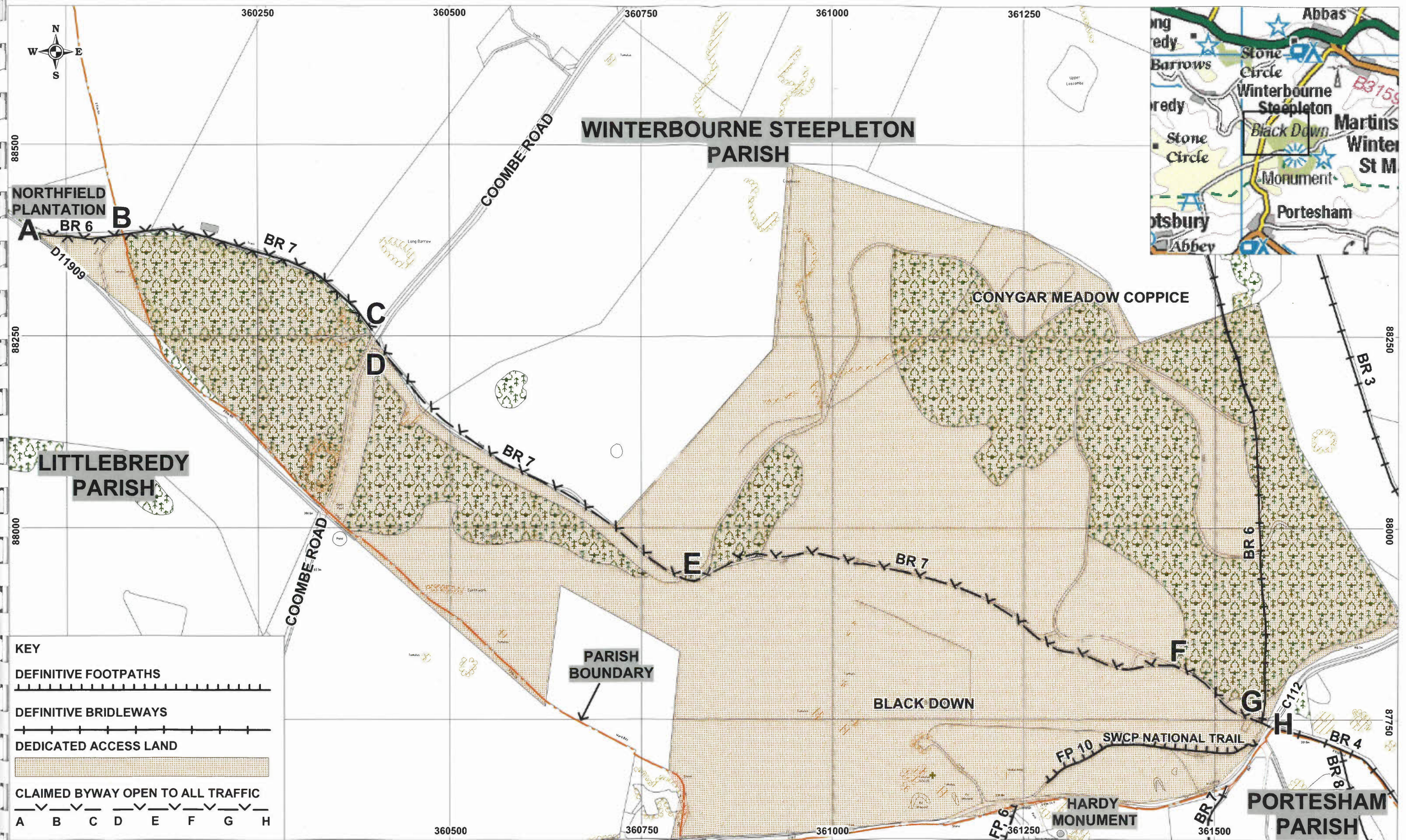
