County of Dorset Definitive Map and Statement of Rights of Way**

**Dorset County Council (Bridleway 8, Winterbourne Steepleton and Part of Bridleway 12
Littlebredy to be Upgraded to Restricted Byways)
Definitive Map and Statement Modification Order 2015**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 19 February 2015.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleway 8, Winterbourne Steepleton and Part of Bridleway 12 Littlebredy to be Upgraded to Restricted Byways) Definitive Map and Statement Modification Order 2015".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Part I

Modification of definitive map Description of ways to be upgraded

Bridleway 8, Winterbourne Steepleton in the West Dorset District:

A – B – C From its junction with Coombe Road, north of Loscombe Plantation and north
– D – E – east of Landlord's Knapp at point A (SY 61378945), north north west along a
F – G – H stone/gravel surfaced track to point B (SY 61368945), east north east of the
barn then generally west through a farmyard, on the northern side of the barn
to the north west of Landlord's Knapp at point C (SY 61278944). Continue
along a grass surface across fields, following the northern fenced field
boundaries, west south west via the field boundary at point D (SY 60608925)
and west north west via the field boundary at point E (SY 60338929) and
continuing west to its junction with Footpath 9 at point F (SY 60278928).
Continue west south west along the northern edge of the field, then crossing
the field boundary to follow the southern side of the field boundary, and
crossing the field boundary again to the north eastern corner of the field at
point G (SY 59958922), then turn north west, through a small area of
woodland and scrub to its junction with Bridleway 12 (to be renumbered
Restricted Byway 13, Littlebredy) at the parish boundary at point H (SY
59938922).

Width: 9.14 metres. Limitation: Field gate at point H (SY 59938922).

Part of Bridleway 12, Littlebredy in the West Dorset District:
(To be renumbered Restricted Byway 13)

H – I From its junction with Bridleway 8, Winterbourne Steepleton at the parish
boundary at point H (SY 59938922), north west across the northern corner of
the field to its junction with Bridleway 12 at the north western field boundary at
point I (SY 59848930).
Width: 5 metres. Limitation: Field gate at point H (SY 59938922).

Bridleway 8, Winterbourne Steepleton

Delete:

From: 613894 To: 599892
Loscombe to parish boundary east of White Hill.

Add:

Restricted Byway 8, Winterbourne Steepleton

From: SY 61378945 To: SY 59938922

From its junction with Coombe Road, north of Loscombe Plantation and north east of Landlord's Knapp, north north west along a stone/gravel surfaced track to SY 61368945, east north east of the barn then generally west through a farmyard, on the northern side of the barn to the north west of Landlord's Knapp at SY 61278944. Continue along a grass surface across fields, following the northern fenced field boundaries, west south west via the field boundary at SY 60608925 and west north west via the field boundary at SY 60338929 and continuing west to its junction with Footpath 9 at SY 60278928. Continue west south west along the northern edge of the field, then crossing the field boundary to follow the southern side of the field boundary, and crossing the field boundary again to the north eastern corner of the field at SY 59958922, then turn north west, through a small area of woodland and scrub to its junction with Restricted Byway 13, Littlebredy at the parish boundary.

Width: 9.14 metres.

Limitation: Field gate at SY 59938922.

Bridleway 12, Littlebredy

Delete:

From: 59938922 To: 59618913

Winterborne Steepleton parish boundary north west, then south westwards for approximately 420 metres to meet the county road at White Hill Lodge.

Add:

Restricted Byway 13, Littlebredy

From: SY 59938922 To: SY 59848930

From its junction with Bridleway 8, Winterbourne Steepleton at the parish boundary, north west across the northern corner of the field to its junction with Bridleway 12 at the north western field boundary.

Width: 5 metres.

Limitation: Field gate at SY 59938922.

Add:

Bridleway 12, Littlebredy

From: SY 59848930 To: 59618913

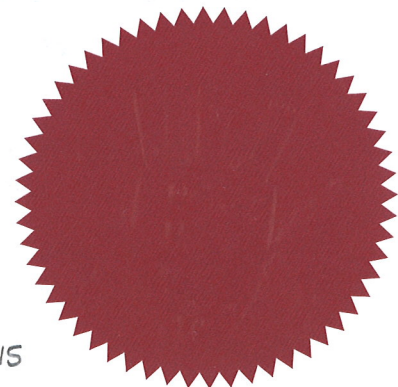
From its junction with Restricted Byway 13, south westwards for approximately 293 metres to meet the county road at White Hill Lodge.
