**Dorset County Council
County of Dorset Definitive Map and Statement of Rights of Way**

Dorset County Council (Bridleway 36, Sixpenny Handley and Pentridge (Bowling Green Lane) to be upgraded to Restricted Byway and a Restricted Byway to be added from Bridleway 36 to Hampshire County Boundary in Sixpenny Handley and Pentridge) Definitive Map and Statement Modification Order 2016

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates; section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 11 April 2016.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleway 36, Sixpenny Handley and Pentridge (Bowling Green Lane) to be upgraded to Restricted Byway and a Restricted Byway to be added from Bridleway 36 to Hampshire County Boundary in Sixpenny Handley and Pentridge) Definitive Map and Statement Modification Order 2016".

SCHEDULE

Bridleway 36, Sixpenny Handley and Pentridge in the East Dorset District:
(*New Restricted Byway 36, Sixpenny Handley and Pentridge*)

A – B – C From its junction with Bowling Green Lane and Footpath 54 at Peaked Post at
– D – E – point A (SU 03091830), north east along an earth and grass surfaced track
F (known as Bowling Green Lane), hedged on both sides, to its junction with
Bridleway 37 at point B (SU 03191843), continuing north east along the track
and through a small area of trees to point C (SU 03511881) then turn east
north east to its junction with Bridleway 40 (Earthpits Lane) at point D (SU
03911889). Continue east north east along a grass surfaced track to its
junction with new Restricted Byway 59 at the north western corner of a field at
point E (SU 04121893) and continuing east across the field to the Hampshire
county boundary, south west of Martin Down at point F (SU 04341894).
The width of varies: 8 metres at point A (SU 03091830), 5 metres at point B
(SU 03191843), 6.5 metres at point C (SU 03511881), 10.6 metres at point D
(SU 03911889), 4.3 metres at point E (SU 04121893) and 3.9 metres at point
F (SU 04341894).

Description of way to be added

Add a Restricted Byway at Sixpenny Handley and Pentridge in the East Dorset District:
(*To be numbered Restricted Byway 59, Sixpenny Handley and Pentridge*)

E – G From its junction with Bridleway 36 (to be upgraded to Restricted Byway) in
the north western corner of a field at point E (SU 04121893), east north east
along a grass surfaced track via its junction with Bridleway 41 to the
Hampshire county boundary south west of Martin Down at point G (SU
04331897).
Width: 4.3 metres at point E (SU 04121893) and 4.6 metres at point G (SU
04331897).

From its junction with Bowling Green Lane and Footpath 54 at Peaked Post, north east along an earth and grass surfaced track (known as Bowling Green Lane), hedged on both sides, to its junction with Bridleway 37 at SU 03191843, continuing north east along the track and through a small area of trees to SU 03511881, then turn east north east to its junction with Bridleway 40 (Earthpits Lane) at SU 03911889. Continue east north east along a grass surfaced track to its junction with Restricted Byway 59 at the north western corner of a field at SU 04121893 and continuing east across the field to the Hampshire county boundary south west of Martin Down. The width varies: 8 metres at SU 03091830, 5 metres at SU 03191843, 6.5 metres at SU 03511881, 10.6 metres at SU 03911889, 4.3 metres at SU 04121893 and 3.9 metres at SU 04341894.

Add:

Restricted Byway 59, Sixpenny Handley and Pentridge

From: SU 04121893 To: SU 04331897

From its junction with Restricted Byway 36, in the north western corner of a field, east north east along a grass surfaced track via its junction with Bridleway 41 to the Hampshire county boundary south west of Martin Down. Width: 4.3 metres at SU 04121893 and 4.6 metres at SU 04331897.

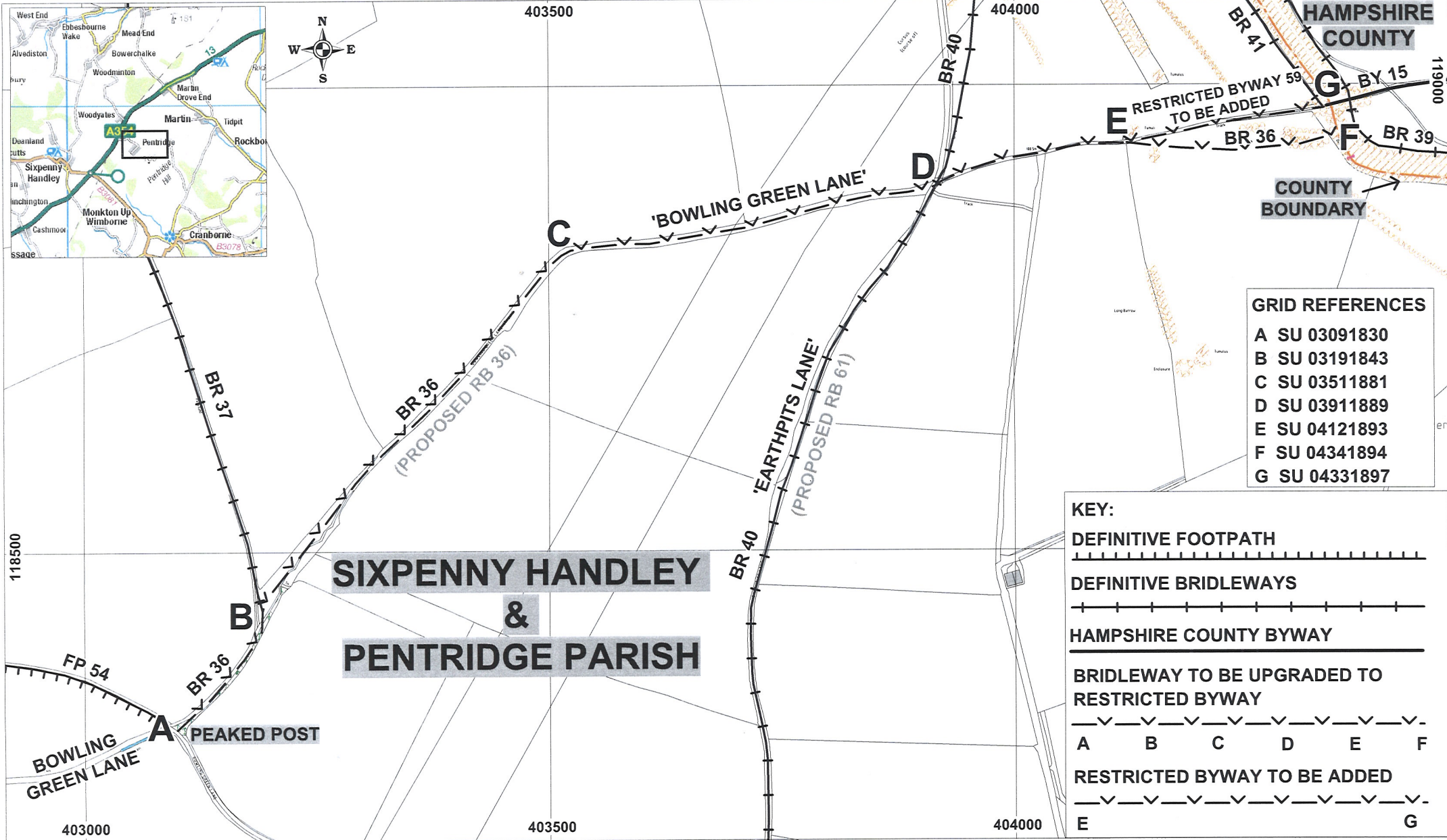
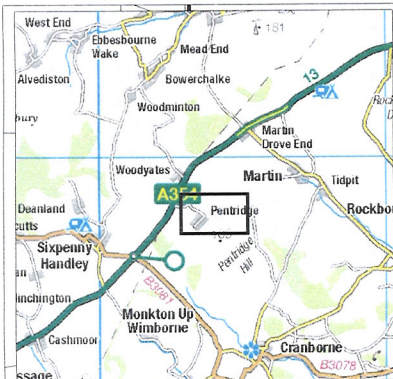
