Definitive Map and Statement Modification Order 2015**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 16 July 2015.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleway 7, Anderson and Bridleway 22, Winterborne Kingston (White Lane) to be upgraded to Restricted Byways) Definitive Map and Statement Modification Order 2015".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Part I

Modification of definitive map Description of ways to be upgraded

Bridleway 7, Anderson in the North Dorset District:

X – Y From its junction with Marsh Lane, south west of Muston Farm Cottages and north west of Marsh Farm at point X (SY 87169734), south for a distance of 34 metres along a grass surfaced track (known as White Lane), hedged on both sides, to its junction with Bridleway 22, Winterborne Kingston at the Winterborne Kingston parish boundary at point Y (SY 87169730).
Width: 8 metres at point X (SY 87169734) narrowing to 6 metres at point Y (SY 87169730).

Bridleway 22, Winterborne Kingston in the North Dorset District:

Y – Z From its junction with Bridleway 7, Anderson, south south west of Muston Farm Cottages at the Anderson parish boundary at point Y (SY 87169730), south along a grassed surfaced track (known as White Lane), for a distance of 744 metres, hedged on both sides, passing to the east of the pond and parallel with the parish boundary, to its junction with Bridleway 8, Anderson, 6 metres north of the A31 trunk road, at the Anderson parish boundary at point Z (SY 87209656).
Width: 6 metres at point Y (SY 87169730), 8 metres between point Y (SY 87169730) and point Z (SY 87209656), 6 metres at point Z (SY 87209656).

Part II

Modification of definitive statement Variation of particulars of ways

Delete:

Bridleway 7, Anderson in the North Dorset District:

From: SY 87169734

To: SY 87169730

White Lane from its junction with Marsh Lane south along a track for a distance of 34 metres to the parish boundary at its junction with Bridleway 22, Winterborne Kingston. The width of the bridleway is 8 metres at its junction with the road, narrowing to 6 metres at its junction with Bridleway 22, Winterborne Kingston.

Add:

Restricted Byway 7, Anderson in the North Dorset District:

From: SY 87169734 To: SY 87169730

From its junction with Marsh Lane, south west of Muston Farm Cottages and north west of Marsh Farm at SY 87169734, south for a distance of 34 metres along a grass surfaced track (known as White Lane), hedged on both sides, to its junction with Restricted Byway 22, Winterborne Kingston at the Winterborne Kingston parish boundary at SY 87169730.
Width: 8 metres at SY 87169734 narrowing to 6 metres at SY 87169730.

Delete:

Bridleway 22, Winterborne Kingston in the North Dorset District:

From: SY 87179730 To: SY 87209656

White Lane from a point 34 metres south of its junction with Marsh Lane at the parish boundary with Anderson, southerly along a track for a distance of 744 metres to a point 6 metres north of the A31 trunk road. The width of the bridleway varies from 6 metres at a point approx 120 metres south of the junction with Marsh Lane to a maximum of 9 metres at a point approx 200 metres north of the junction with the A31.


Restricted Byway 22, Winterborne Kingston in the North Dorset District:

From: SY 87169730 To: SY 87209656

From its junction with Restricted Byway 7, Anderson at the Anderson parish boundary at SY 87169730, south along a grassed surfaced track (known as White Lane) for a distance of 744 metres, hedged on both sides, passing to the east of the pond and parallel with the parish boundary, to its junction with Bridleway 8, Anderson, 6 metres north of the A31 trunk road, at the Anderson parish boundary at SY 87209656.
Width: 6 metres at SY 87169730, 8 metres between SY 87169730 and SY 87209656, 6 metres at SY 87209656.

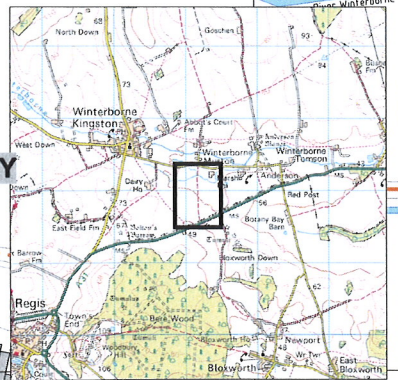
