Definitive Map and Statement Modification Order 2016**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 16 December 2015.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleway 11, Weymouth, Bridleway 24, Osmington and Bridleways 9 and 5, Poxwell to be Upgraded to Restricted Byways) (Part of the South West Coast Path National Trail) Definitive Map and Statement Modification Order 2016".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Part I

Modification of definitive map Description of ways to be upgraded

Bridleway 11, Weymouth in the Weymouth & Portland Borough:
(To be renumbered Restricted Byway 11, Weymouth)

A – B – C From its junction with the county road, Bridleway 11, Broadmayne and Footpath 3, Weymouth at point A (SY 70998478), south east, running parallel with the Poxwell parish boundary, along a gravel/stone surfaced track, to its junction with Bridleway 10 at point B (SY 71038474), continuing generally south east along the track to its junction with Bridleway 24, Osmington (proposed Restricted Byway 24) at the Osmington parish boundary at point C (SY 71428451). Width: 5 metres. Limitation: Field gate at point C (SY 71428451).

Bridleway 24, Osmington in the West Dorset District:
(To be renumbered Restricted Byway 24, Osmington)

C – D – E From its junction with Bridleway 11, Weymouth (proposed Restricted Byway
– F – G 11) at the Weymouth parish boundary at point C (SY 71428451), east, running parallel with the Poxwell parish boundary and following the northern field boundary, along a grass and earth surfaced track, fenced and hedged on the northern side, to its junction with Footpath 23 and Bridleway 26 at point D (SY 71858445), then east south east, passing its junction with Bridleway 8, Poxwell at point E (SY 71898444), and crossing the field boundary at point F (SY 72268432). Continue east south east, along a grass surfaced track, fenced on both sides, to its junction with Bridleway 9, Poxwell (proposed Restricted Byway 9) at the Poxwell parish boundary at point G (SY 72468425). Width: 5 metres. Limitations: Field gates at points C (SY 71428451), D (SY 71858445) and F (SY 72268432).

Bridleway 9, Poxwell in the West Dorset District:
(To be renumbered Restricted Byway 9, Poxwell)

G – H – I From its junction with Bridleway 24, Osmington (proposed Restricted Byway
– J – K - 24) at the Osmington parish boundary at point G (SY 72468425), east south east, along a grass surfaced track running parallel with the Osmington parish boundary and crossing the field boundaries at points H (SY 72748420) and I (SY 72958416), then east to point J (SY 73188411). Continue east, then south east, crossing the field boundary at point K (SY 73448407), then south, crossing the field boundary at point L (SY 73478402) and continuing south south east, passing to the east of Pixon Barn, to its junction with Bridleway 5 (proposed Restricted Byway 5) and Bridleway 6, south east of Pixon Barn at point M (SY 73568384). The width varies: 5 metres between points G (SY 72468425) and J (SY 73188411), 15 metres at point J (SY 73188411) widening to 20 metres between points J (SY 73188411) and K (SY 73448407), 15 metres at point K (SY 73448407), narrowing to 4 metres between points K (SY 73448407) and L (SY 73478402), 4 metres at point L (SY 73478402) and 3 metres between points L (SY 73478402) and M (SY 73568384). Limitation: Field gate at point J (SY 73188411).

Bridleway 5, Poxwell in the West Dorset District:
(To be renumbered Restricted Byway 5, Poxwell)

M – N – From its junction with Bridleway 9 (proposed Restricted Byway 9) and
O – O1 – Bridleway 6, south east of Pixon Barn at point M (SY 73568384), south east
P along a stone/flint surfaced track, crossing the field boundary at point N (SY
73608381), then continuing south east, along a grass surfaced track, across a
field and crossing the field boundary at point O (SY 73818364) and south east
to point O1 (SY 74018355). Continue east south east along a stone/flint
surfaced track to its junction with the A353 road at point P (SY 74208350)
Width: 3 metres. Limitation: Field gate at point M (SY 73568384).

the track to its junction with Restricted Byway 24, Osmington at the Osmington parish
boundary. Width: 5 metres. Limitation: Field gate at SY 71428451.

From: 714845 To: 724842
Weymouth borough boundary at East Hill to Poxwell parish boundary, White Horse Hill.

Add:

Restricted Byway 24, Osmington in the West Dorset District:
From: SY 71428451 To: SY 72468425
From its junction with Restricted Byway 11, Weymouth at the Weymouth parish boundary,
east, running parallel with the Poxwell parish boundary and following the northern field
boundary, along a grass and earth surfaced track, fenced and hedged on the northern side, to
its junction with Footpath 23 and Bridleway 26 at SY 71858445, then east south east, passing
its junction with Bridleway 8, Poxwell at SY 71898444 and crossing the field boundary at SY
72268432. Continue east south east, along a grass surfaced track, fenced on both sides, to its
junction with Restricted Byway 9, Poxwell at the Poxwell parish boundary. Width: 5 metres.
Limitations: Field gates at SY 71428451, SY 71858445 and SY 72268432.

Bridleway 9, Poxwell in the West Dorset District:
From: 735838 To: 724842
Path No 6 at Pixon Barn to Osmington parish boundary on White Horse Hill.

Add:

Restricted Byway 9, Poxwell in the West Dorset District:

From: SY 72468425 To: SY 73568384

From its junction with Restricted Byway 24, Osmington at the Osmington parish boundary, east south east, along a grass surfaced track running parallel with the Osmington parish boundary, crossing the field boundaries at SY 72748420 and SY 72958416, and continuing east to SY 73188411. Continue east, then south east, crossing the field boundary at SY 73448407, then south, crossing the field boundary at SY 73478402 and continuing south south east, passing to the east of Pixon Barn, to its junction with Restricted Byway 5 and Bridleway 6, south east of Pixon Barn at SY 73568384. The width varies: 5 metres between SY 72468425 and SY 73188411, 15 metres at SY 73188411, widening to 20 metres between SY 73188411 and SY 73448407, 15 metres at SY 73448407, narrowing to 4 metres between SY 73448407 and SY 73478402, 4 metres at SY 73478402 and 3 metres between points SY 73478402 and SY 73568384. Limitation: Field gate at SY 73188411.

From its junction with Bridleway 6 and Restricted Byway 9 and, south east of Pixon Barn, south east along a stone/flint surfaced track, crossing the field boundary at SY 73608381, then continuing south east, along a grass surfaced track, across a field and crossing the field boundary at SY 73818364, and south east to SY 74018355. Continue east south east along a stone/flint surfaced track to its junction with the A353 road. Width: 3 metres. Limitation: Field gate at SY 73568384.

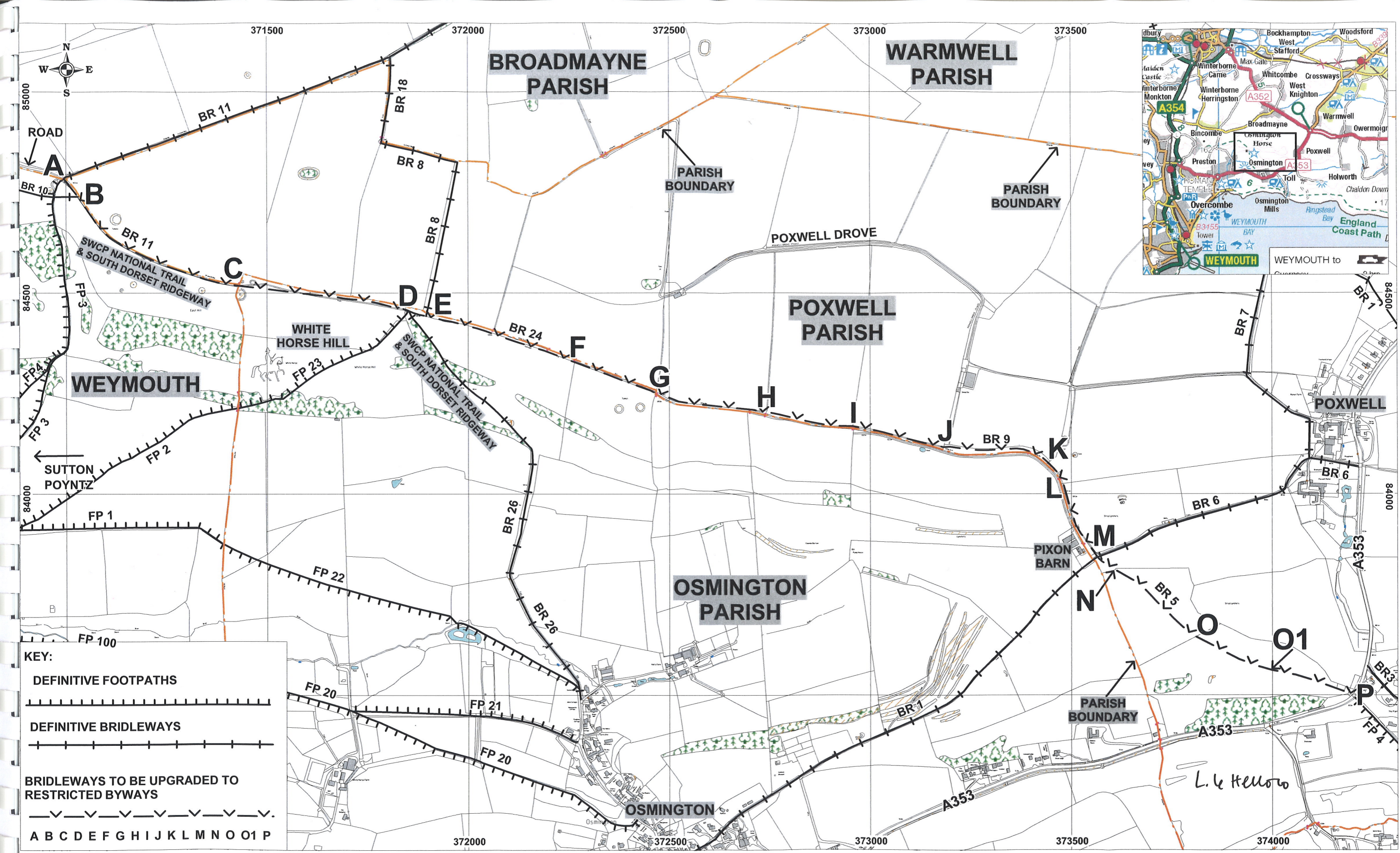
