Definitive Map and Statement Modification Order 2016**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii) namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and section 53(3)(c)(iii) namely, any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 16 December 2015.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Bridleway 26, Osmington to be upgraded to Restricted Byway) (Part of the South West Coast Path National Trail) Definitive Map and Statement Modification Order 2016".

SCHEDULE

Part I

Modification of definitive map Description of way to be upgraded

Bridleway 26, Osmington in the West Dorset District:
(to be renumbered *Restricted Byway 26, Osmington*)

- A – B – C From its junction with Church Lane, north north west of Summerlands and
– D Osmington village at point A (SY 72278353), north west along an earth and
stone surfaced track, hedged on both sides to point B (SY 72108379), then
north north east along the track to point C (SY 72158411). Turn north west,
along open pasture and through a small area of woodland at White Horse Hill
to its junction with Footpath 23 and Bridleway 24 at the Poxwell parish
boundary at point D (SY 71858455).
The width varies: 8 metres at point A (SY 72278353), 10 metres between
points A (SY 72278353) and B (SY 72108379), 12 metres at point B (SY
72108379), widening to 22 metres between points B (SY 72108379) and C
(SY 72158411), 22 metres at point C (SY 72158411), narrowing to 3 metres
between points C (SY 72158411) and D (SY 71858455).
Limitation: Field gate at point C (SY 72158411).

Bridleway 26, Osmington in the West Dorset District:

From: 722834 To: 71884

Osmington village northwards to join Path No 24 on White Horse Hill.

Add:

Restricted Byway 26, Osmington in the West Dorset District:

From: SY 72278353 To: SY 71858455

From its junction with Church Lane, north north west of Summerlands and Osmington village, north west along an earth and stone surfaced track, hedged on both sides to SY 72108379, then north north east along the track to SY 72158411. Turn north west, along open pasture and through a small area of woodland at White Horse Hill to its junction with Footpath 23 and Bridleway 24 at the Poxwell parish boundary.

The width varies: 8 metres at SY 72278353, 10 metres between SY 72278353 and SY 72108379, 12 metres at SY 72108379, widening to 22 metres between SY 72108379 and SY 72158411, 22 metres at SY 72158411, narrowing to 3 metres between SY 72158411 and SY 71858455. Limitation: Field gate at SY 72158411.
