Definitive Map and Statement Modification Order 2016**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that there is no public right of way over land shown in the map and statement as highway of any description and that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The Dorset County Council hereby order that:

1. For the purposes of this Order the relevant date is 21 January 2016.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Parts of Bridleway 18, Castleton (Ratleigh Lane) to be deleted and Restricted Byways at Castleton to be added (Ratleigh Lane)) Definitive Map and Statement Modification Order 2016".

SCHEDULE

(The points specified relate to the map attached to the Order and their positions are identified by national grid references)

Part I

Modification of definitive map Description of way to be deleted

Parts of Bridleway 18, Castleton in the West Dorset District:

- B – E From its junction with Bridleway 19 (known as Gooseland Lane) at point B (ST 61351745), south west along the northern field boundary, running parallel with Ratleigh Lane and the Nether Compton parish boundary for 160 metres to point E (ST 61241734). (No recorded width).
- H - J From its junction with the D20156 public road (part of Ratleigh Lane), north east of the poultry farm at point H (ST 61001718), south west along the western field boundary, parallel with Ratleigh Lane to its junction with the D20156 public road (part of Ratleigh Lane) at the Nether Compton parish boundary at point J (ST 6086516875). (No recorded width).

Description of ways to be added

Restricted Byway 18, Castleton in the West Dorset District:

- A – C – D From its junction with the D20150 public road (known as Charlock Hill or
– F Checombe Lane) at point A (ST 61361747), south west along a stone surfaced track (known as Ratleigh Lane), running parallel with the Nether Compton Parish boundary to its junction with Bridleway 15 (known as Guineagore Lane) at point C (ST 61271738), continuing south west, via point D (ST 61231734), to its junction with the D20156 public road (part of Ratleigh Lane) at point F (ST 61141728). The width varies: 9 metres at point A (ST 61361747), 8 metres at point C (ST 61271738), narrowing to 6.6 metres at point D (ST 61231734) and 5.8 metres at point F (ST 61141728).

Restricted Byway 27, Castleton in the West Dorset District:

- H – K From its junction with the D20156 public road, north east of the poultry farm at point H (ST 61001718), south south west along a stone surfaced track (known as Ratleigh Lane), running parallel with the Nether Compton Parish boundary and passing to the east of the poultry farm, to its junction with the D20156 public road (part of Ratleigh Lane), east of Ratleigh Wood, at the Nether Compton parish boundary at point K (ST 6086116878). The width varies: 6.7 metres at point H (ST 61001718), widening to 8 metres at point K (ST 6086116878).

From its junction with the D20150 public road (known as Charlock Hill or Checcombe Lane), south west along a stone surfaced track (known as Ratleigh Lane), running parallel with the Nether Compton Parish boundary to its junction with Bridleway 15 (known as Guineagore Lane) at ST 61271738, continuing south west, via ST 61231734, to its junction with the D20156 public road. The width varies: 9 metres at ST 61361747, 8 metres at ST 61271738, narrowing to 6.6 metres at ST 61231734 and 5.8 metres at ST 61141728.

Add:

Restricted Byway 27, Castleton in the West Dorset District:

From: ST 61001718 To: ST 6086116878

From its junction with the D20156 public road, north east of the poultry farm, south south west along a stone surfaced track (known as Ratleigh Lane), running parallel with the Nether Compton Parish boundary and passing to the east of the poultry farm, to its junction with the D20156 public road, east of Ratleigh Wood, at the Nether Compton parish boundary. The width varies: 6.7 metres at ST 61001718, widening to 8 metres at ST 6086116878.

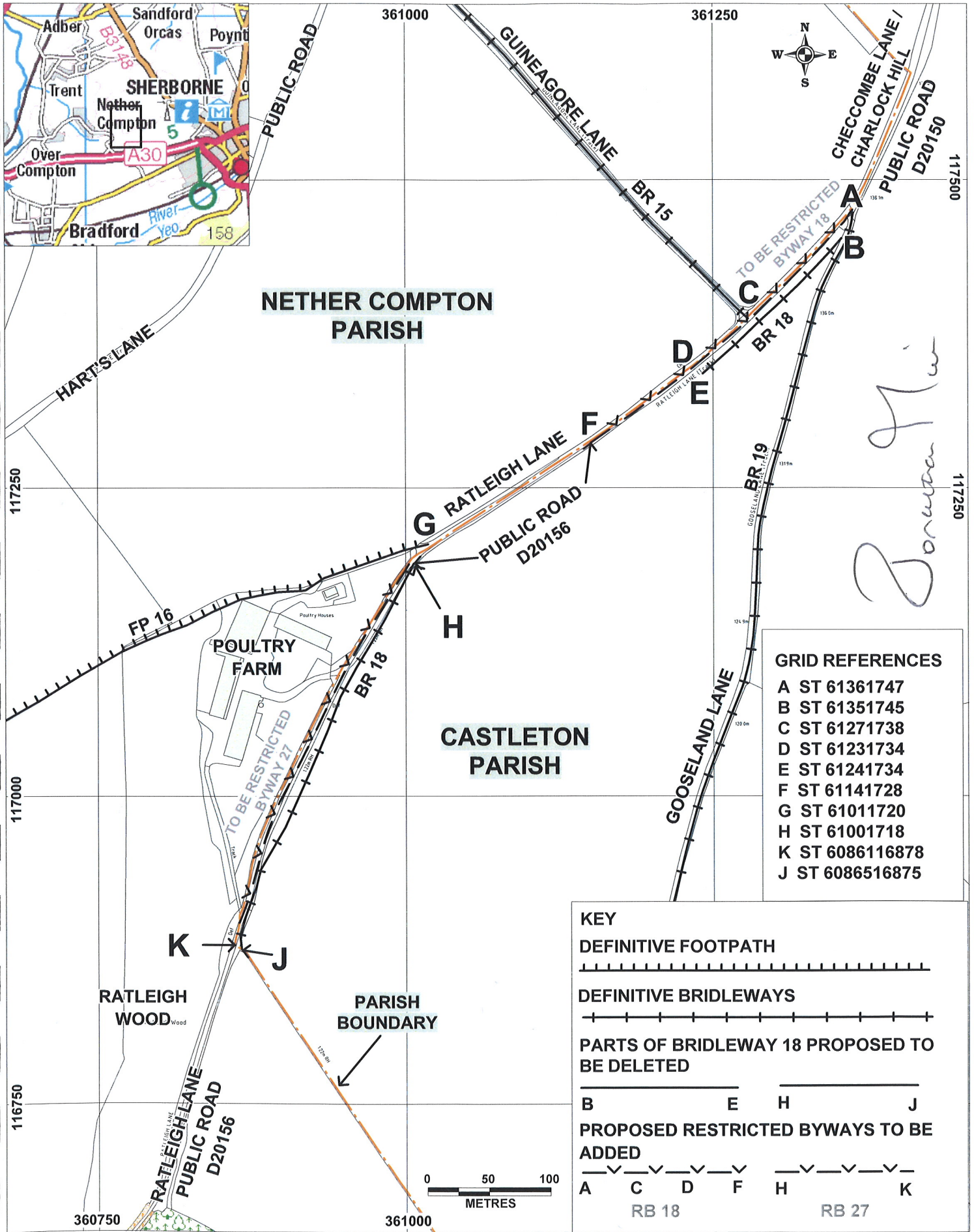
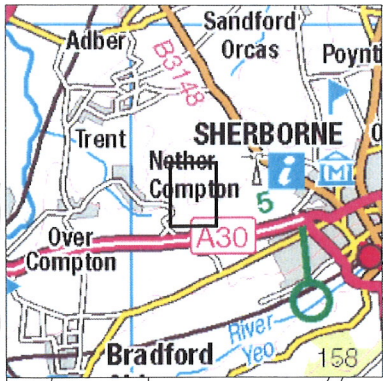
