This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

1. For the purposes of this Order the relevant date is 22 January 2020.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (A Footpath at School Lane, Pimperne) Definitive Map and Statement Modification Order 2020".

### Part I

#### **Modification of definitive map Description of path to be added**

##### A Footpath, Pimperne:

*To be numbered Footpath 30, Pimperne*

B – B1 – From its junction with School Lane, south of The School House at point B (ST 90610938), east north east along a tarmac surfaced path, fenced on the southern side to point B1 (ST 9061609388) and continuing east north east, passing to the north of Harrow House and Eton House (via point C (ST 90620939)) to the western side of the sports field (of the former Pimperne First School) at point D (ST 90630939). The width varies: 2.5 metres at point B (ST 90610938), 2.9 metres between points B (ST 90610938) and B1 (ST 9061609388), widening to 4.9 metres at point B1 (ST 9061609388), 3.7 metres at point C (ST 90620939) and 4.2 metres at point D (ST 90630939).  
Limitation: Pedestrian gate at point D (ST 90630939) to BS5709:2018.

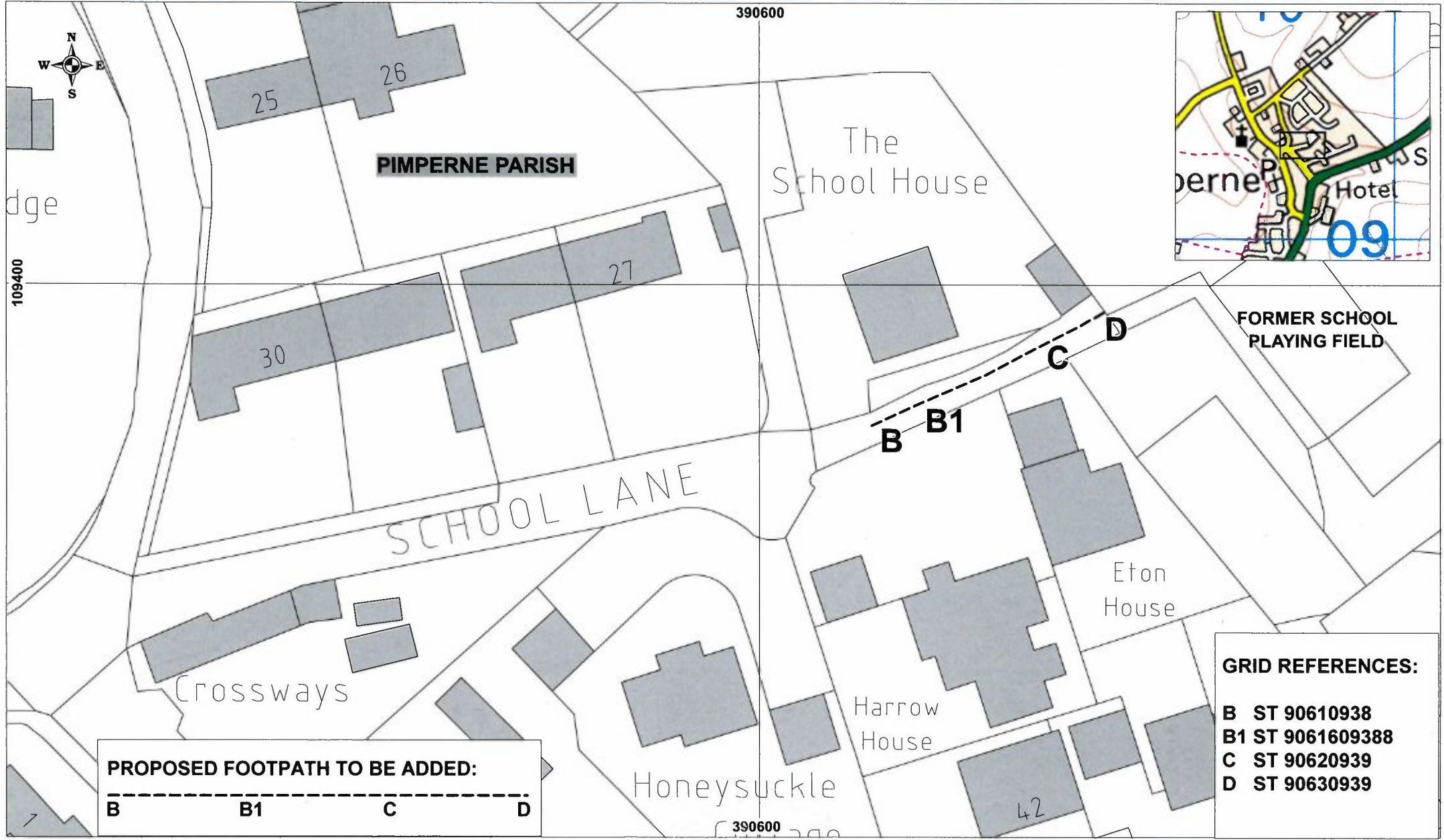

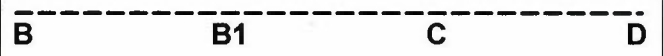
