**Dorset Council (A Footpath from Portwey Close to Rodwell Road, Weymouth)
Definitive Map and Statement Modification Order 2022**

This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

1. For the purposes of this Order the relevant date is 31 August 2022.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (A Footpath from Portwey Close to Rodwell Road, Weymouth) Definitive Map and Statement Modification Order 2022".

(to be numbered Footpath 164, Weymouth)

A-B-C From its junction with Portwey Close, between property numbers 31 and 33 at point A (SY 6751 7827), east along a concrete surfaced track for 75 metres (via point B (SY 6755 7828)) to its junction with Rodwell Road, between property numbers 34 and 36 at point C (SY 6758 7828). Width: 1.8 metres at point A (SY 6751 7827), widening to 3.1 metres between point B (SY 6755 7828) and point C (SY 6758 7828).

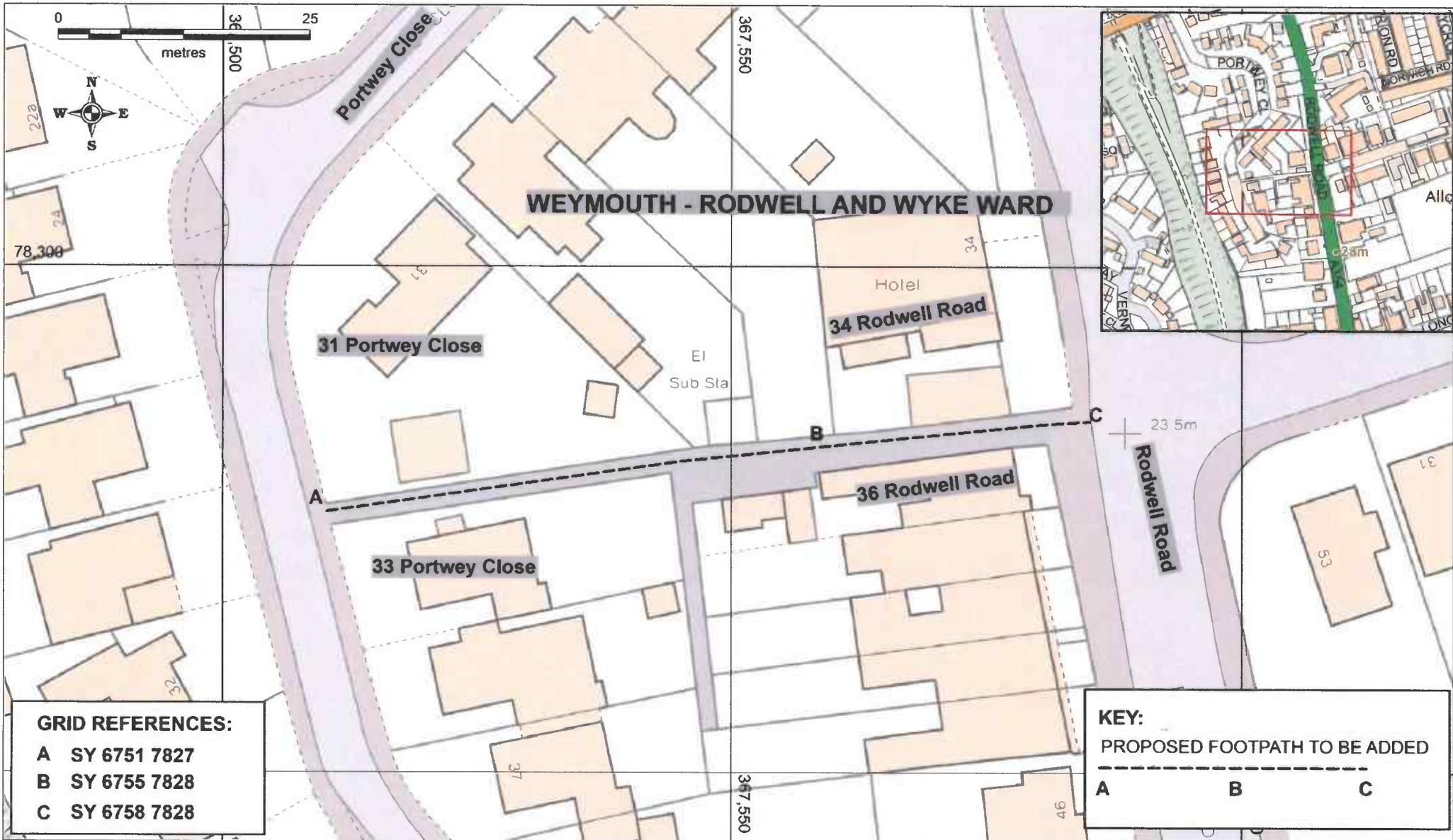
Modification of definitive statement Variation of particulars of path

Add:

From: SY 6751 7827 To: SY 6758 7828

From its junction with Portwey Close, between property numbers 31 and 33, east along a concrete surfaced track for 75 metres (via SY 6755 7828) to its junction with Rodwell Road, between property numbers 34 and 36. Width: 1.8 metres at SY 6751 7827, widening to 3.1 metres between SY 6755 7828 and SY 6758 7828.
