Westbury to South Street, Sherborne

A wide tarmac'd track leaves Westbury beside Weaver Club CP
It narrows past two houses (Terra View) and the widens tremendously for
turning space before a wire fence.

The fence has a gap in the middle - c. 3' wide - for walkers to pass through.

The road through the ~~Sherborne~~ ^{Southern Western} Business Park passes various sized buildings
and necessitates a right angle bend to get down to join the lane from
Valmiera Glen UK Ltd to South Street, passing through the Station - CP.
(This, too, narrows past The Railway Shed and widens indeterminately through
the CP).
