Definitive Map and Statement Modification Order 2024

This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

1. For the purposes of this Order the relevant date is 06 November 2023.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (A Footpath at Eweleaze Spinneys, Chickerell (leading to and from Grafton Avenue, Weymouth)) Definitive Map and Statement Modification Order 2024".

A Footpath, Chickerell:

(to be numbered Footpath 58, Chickerell)

A-B-C-D-E-F-G-A Commencing at the Weymouth Parish boundary at the western end of Grafton Avenue, between property numbers 41 and 42, at point A (SY 6602, 8096) at the junction with definitive footpath S16/48, north-west to point B (SY 6595, 8099); west-south-west along the northern edge of the arable grassed field adjacent to Eweleaze Spinneys to point C at the junction with definitive footpath S16/49 (SY 6585, 8095); south-west towards the woodland to point D (SY 6582, 8089); south-south-east parallel with the woodland to point E (SY 6594, 8065); east-north-east to point F at the junction with definitive footpath S16/48 (SY 6602, 8067); east-north-east along the southern boundary of the arable grassed field to point G (SY 6609, 8069); north-north-west past the rear of the housing to point A (SY 6602, 8096).

Width: 1.5 metres at point A (SY 6602, 8096) continuing at 1.5m to point B (SY, 6595, 8099); widening to 3 metres at point B (SY 6595, 8099) continuing at 3m to point C (SY 6585, 8095); narrowing to 1.5m at point C (SY 6585, 8095), and remaining at 1.5 metres between point D (SY 6582, 8089), point E (SY 6594, 8065), point F (SY 6602, 8067), point G (SY 6609, 8069) and point A (SY 6602, 8096).

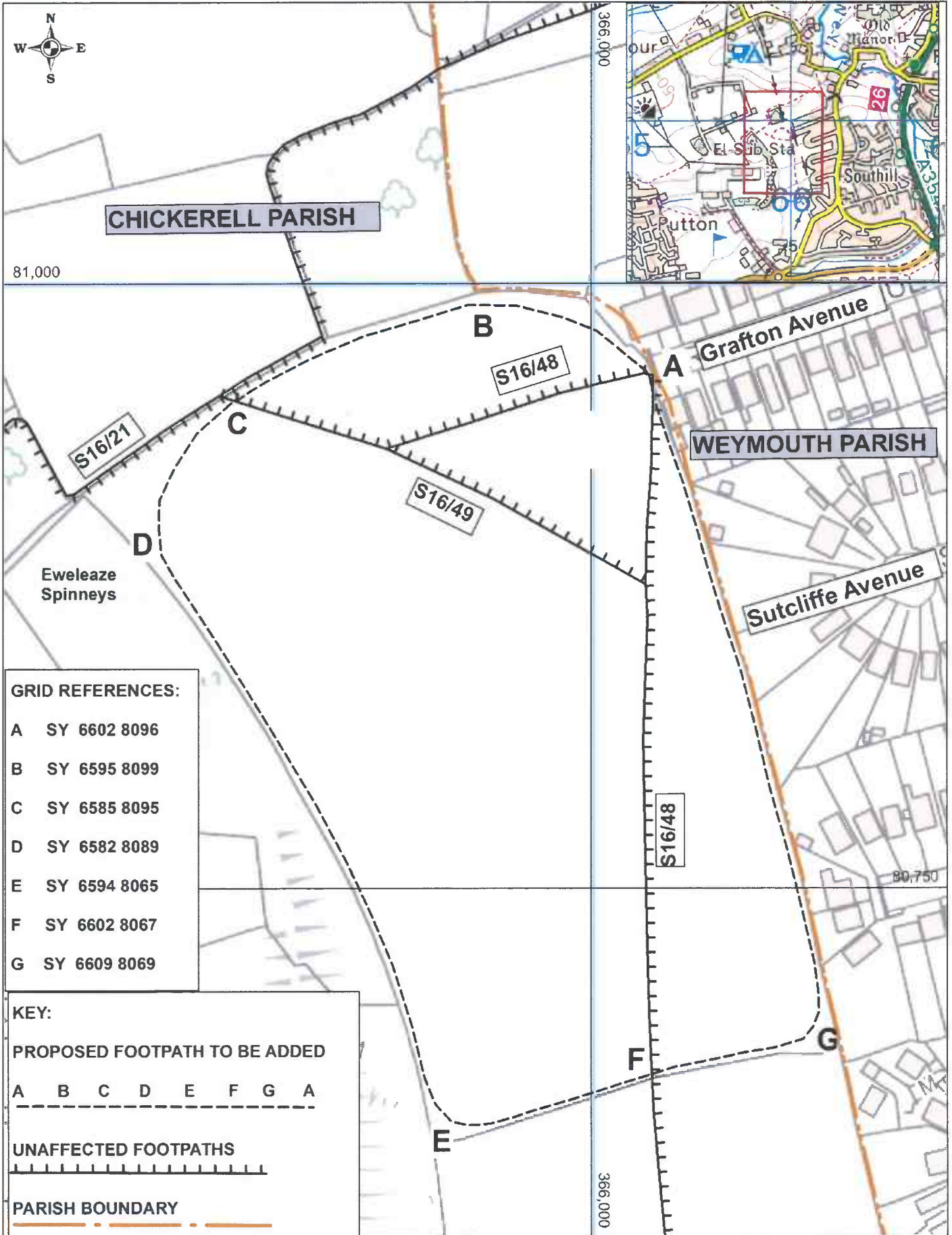

From its commencement at the Weymouth Parish boundary, at the western end of Grafton Avenue, between property numbers 41 and 42, at SY 6602, 8096 at the junction with definitive footpath S16/48, north-west to SY 6595, 8099; west-south-west along the northern edge of the arable grassed field adjacent to Eweleaze Spinneys to the junction with definitive footpath S16/49 at SY 6585, 8095; south-west towards the woodland to SY 6582, 8089; south-south-east parallel with the woodland to SY 6594, 8065; east-north-east to the junction with definitive footpath S16/48 at SY 6602, 8067; east-north-east along the southern boundary of the arable grassed field to SY 6609, 8069; north-north-west past the rear of the housing to SY 6602, 8096.

Width: 1.5 metres at SY 6602, 8096 continuing at 1.5m to SY, 6595, 8099; widening to 3 metres at SY 6595, 8099 continuing at 3m to SY 6585, 8095; narrowing to 1.5m at SY 6585, 8095, and remaining at 1.5 metres between SY 6582, 8089, SY 6594, 8065, SY 6602, 8067, SY 6609, 8069 and SY 6602, 8096.
